



## Reminder for Webmasters

If you are the webmaster of a certified Society website, it is now time to submit your request for website recertification. At the beginning of each international biennium, certified websites must be recertified. Submit Form 72 in order to apply for recertification. This form is available on the Society website, under the heading *Website Forms*, from the *Forms* drop-down menu.

The Communications and Publicity Committee will be accepting recertification requests from September 2 until the deadline of October 31. Send forms to [dkgswanson@gmail.com](mailto:dkgswanson@gmail.com). If a recertification application is not received by the deadline, the website is at risk of being unlinked from the international website.

First time certification may be applied for at any time.

## Chapter Facebook Page

A chapter can have its own private forum for members by creating a group Facebook page. To begin, members must join Facebook. One need not participate in Facebook but must have an account in order to join the private chapter group. The person who creates the group is the site administrator.

The administrator must go to her home page and follow these steps:

- Locate *Groups* on the left column and scroll down to *Create Group*.
- Click on *Create Group*. Add group name in the top box and members' names in the second box.
- Choose your privacy setting, such as *Friends*.
- Click *Create*.

Now your group page is created and you can add a group description, pictures, events and files. New members can be added to the group upon request. Enjoy communicating privately on Facebook!

**Two- and Three-Dimensional Art** covers the media of acrylic, charcoal, color pencil, graphite, installation art, multi-media, mixed media, oil, pastel, pen and ink, woodblock, print-making, water color and sculpture.

**Photography** includes color and black and white, while the **Crafts** category includes ceramics, jewelry, textiles, basketry, pottery and quilts.
